EXHIBIT "A"

PARCEL 1:

Commencing at the centerline intersection of Seventeenth Street and College Avenue as described in a deed to the City of Santa Ana recorded June 24, 1955, in Book 3117, page 160, official records; thence North 00° 47' 00" East 52.03 feet along the centerline of said College Avenue to the True Point of Beginning; thence North 00° 47' 00" East 165.47 feet to a point of cusp on a non-tangent curve concave Northeasterly having a radius of 180.59 feet to which point of cusp a radial line bears South 60° 06' 20" West; thence Southeasterly through a central angle of 07° 38' 43" an arc distance of 24.10 feet to a point of reverse curvature; thence Southeasterly along a curve concave Southwesterly having a radius of 153.00 feet through a central angle of 38° 19' 23" an arc distance of 102.34 feet to a tangent line; thence South 00° 47' 00" West 25.02 feet to a tangent curve concave Northwesternly having a radius of 25.00 feet; thence Southwesterly along said curve through a central angle of 88° 05' 40" an arc distance of 38.44 feet to a tangent line, said tangent line being parallel and distant Northerly 52.00 feet, measured at right angles, to said centerline of Seventeenth Street; thence South 88° 52' 40" West along last said parallel line 22.45 feet to the True Point of Beginning.

EXCEPTING therefrom that portion lying Easterly of the following described line:

Commencing at the hereinabove previously described centerline intersection of Seventeenth Street and College Avenue; thence North 00° 47' 00" East 300.00 feet along the centerline of College Avenue; thence South 89° 13' 00" East 27.00 feet to a point on the East line of College Avenue being also the True Point of Beginning; thence South 00° 47' 00" West 223.23 feet along the East line of College Avenue to a tangent curve concave Northeasterly having a radius of 25.00 feet; thence Southeasterly along said curve through a central angle of 91° 54' 20" an arc distance of 40.10 feet to a tangent line, said tangent line being parallel and distant Northerly 50.10 feet, measured at right angles, to said centerline of Seventeenth Street.

PARCEL 2:

Commencing at the centerline intersection of Seventeenth Street and College Avenue as described in a deed to the City of Santa Ana recorded June 24, 1955, in Book 3117, page 160, official records; thence North 88° 52' 40" East 187.45 feet along the centerline of Seventeenth Street; thence North 01° 02' 20" West 50.00 feet along a line perpendicular to said centerline of Seventeenth Street to a point on a line parallel to and distant 50.00 feet Northerly, measured at right angles, from said centerline; thence South 88° 52' 40" West along said parallel line 1.00 foot to the True Point of Beginning; thence Northwesternly along a tangent curve concave Northeasterly having a radius of 25.00 feet through a central angle of 90° 54' 20" an arc distance of 40.10 feet to a tangent line; thence North 00° 47' 00" East 23.23 feet to a tangent curve concave Southwesterly having a radius of 217.00 feet; thence Northwesternly along said curve through a central angle of 38° 19' 23" an arc distance of 145.14 feet to a point of reverse curvature; thence Northwesternly along a curve concave Northeasterly having a radius of 163.00 feet through a central angle of 38° 19' 23" an arc distance of 109.02 feet to a point on a tangent line, said point being a point of cusp, said tangent line being parallel to and distant Easterly 27.00 feet measured at right angles, to the centerline of said College Avenue; thence South 00° 47' 00" West 261.59 to a tangent curve concave Northeasterly having a radius of 25.00 feet; thence Southeasterly along said curve through a central angle of 91° 54' 20" an arc distance of 40.10 feet to a tangent line, said tangent being parallel to and distant Northerly 50.00 feet, measured at right angles, to said centerline of Seventeenth Street; thence North 88° 52' 40" East along last said parallel line to the True Point of Beginning.
