Beginning at the intersection of the northeasterly line of said Parcel 102 with a curve concentric with and 60.00 feet northwesterly of that certain curve in the construction centerline of Alton Parkway having a radius of 2,470.00 feet, a length of 527.34 feet, and a central angle of 12°13′57″, as shown on Record of Survey No. 2012-1066, filed December 4, 2012 in Book 261, Pages 11 through 14 of Records of Survey in said County Recorder's Office, said concentric curve being on the proposed northwesterly right-of-way line of Alton Parkway as shown on said Record of Survey, concave southerly and having a radius of 2,530.00 feet, a radial line to said intersection bears North 25°06'24" West; thence along said curve Southwesterly 112.58 feet through a central angle of 02°32′59"; thence leaving said proposed right-of-way line North 27°39′23" West, 0.17 feet to the beginning of a non-tangent curve, concave northwesterly and having a radius of 15.00 feet, a radial line to said curve bears South 27°39'23" East; thence Southwesterly 2.02 feet along said curve through a central angle of 07°42′09"; thence South 70°02′46" West, 16.05 feet to the beginning of a curve, concave southeasterly and having a radius of 15.00 feet; thence Southwesterly 2.14 feet along said curve through a central angle of 08°09'21" to the beginning of a compound curve, concave southeasterly and having a radius of 2,532.67 feet, said curve being concentric with and 62.67 feet northwesterly of said construction centerline; thence along said curve Southwesterly 36.00 feet through a central angle of 00°48'52" to the beginning of a compound curve, concave southeasterly and having a radius of 15.00 feet; thence Southwesterly 2.14 feet along said curve through a central angle of 08°09'21"; thence South 52°55'13" West, 16.05 feet to the beginning of a curve, concave northwesterly and having a radius of 15.00 feet; thence Southwesterly 2.02 feet along said curve through a central angle of 07°42′09"; thence South 29°22'39" East, 0.17 feet to the beginning of a non-tangent curve, in said proposed northwesterly right-of-way line, concave southeasterly and having a radius of 2,530.00 feet, a radial line to said curve bears North 29°22'39" West; thence along said curve Southwesterly 170.78 feet through a central angle of 03°52′03"; thence South 56°45′18" West, 105.48 feet; thence leaving said proposed right-of-way line North 27°20′51" West, 15.84 feet; thence North 24°33'18" West, 1.79 feet; thence North 39°44'34" West, 35.68 feet; thence North 50°36'38" East, 82.93 feet; thence North 59°11'03" East, 50.64 feet; thence North 54°34'30" East, 31.05 feet; thence North 50°36'46" East, 123.99 feet; thence North 43°08'00" East, 27.26 feet; thence North 55°49'50" East, 23.88 feet; thence North 82°05'02" East, 41.05 feet; thence South 82°40'43" East, 41.24 feet; thence North 68°01'19" East, 45.19 feet to said northeasterly line of Parcel 102; thence along said northeasterly line South 49°17′28" East, 55.38 feet to the POINT OF BEGINNING.
