non-tangent curve, concave northerly and having a radius of 134.00 feet, a radial line to said curve bears South 36°06′25″ West; thence Easterly 83.96 feet along said curve through a central angle of 35°53′53″; thence North 82°26′20″ East 30.85 feet to the beginning of a curve, concave southerly and having a radius of 25.00 feet; thence Easterly 24.37 feet along said curve through a central angle of 55°51′39″; thence South 41°42′01″ East 42.70 feet to the TRUE POINT OF BEGINNING.
