GRANT OF EASEMENT

THE GRANTOR COUNTY OF ORANGE

other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone
and/or other purposes.

Said real property is described as follows:

The southerly 6 feet of Lot 29 and of the westerly 50 feet of Lot 28;
The northerly 6 feet of the westerly 710 feet of Lot 35;

Said lots being in the Dunn Tract, as per map recorded in Book 8,
page 21 of Miscellaneous Maps, records of Orange County.
