RELINQUISHMENT OF HIGHWAY RIGHT OF WAY IN THE
COUNTY OF ORANGE, ROAD 07-ORA-97-21.9
REQUEST NO. 842

WHEREAS, by freeway agreement dated November 3, 1971,
between the County of Orange and the State of California, the
County agreed to accept title to a reconstructed county road,
upon relinquishment thereof to said County by the State of
California; and

WHEREAS, the State of California has acquired right of
way for and has constructed the above mentioned collateral faci-
lities in the County of Orange, at Tomner Canyon Road, Road 07-ORA-57,
in accordance with said agreement; and

WHEREAS, this Commission has found and determined, and
does hereby find and determine, that it is desirable and in the
public interest that said collateral facilities be relinquished
to the County of Orange for use as a county highway;

NOW, THEREFORE, IT IS VOTED by the California Highway
Commission that it relinquish, and it does hereby relinquish,
to the County of Orange, effective upon the recordation of a
certified copy hereof with the Recorder of Orange County, all of
the State of California's right, title and interest in and to
said collateral facilities in said County, together with the right
of way and appurtenances thereof, described as follows:

All those portions of a reconstructed county road shown as Parcels 1 and 2 as delineated and shaded on maps recorded on August 4, 1972 in State Highway Map Book No. 8, pages 22 and 23, Records of Orange County.

EXCEPTING AND RESERVING to the State of California any and all rights of ingress to and egress from the highway hereby relinquished in and to the adjoining freeway, except at such points as now are or may be established by resolution of this Commission.
