GRANT TO

SOUTH EAST REGIONAL RECLAMATION AUTHORITY OF EASEMENT FOR DRAINAGE PURPOSES BY CAPISTRANO BAY PARK AND RECREATION DISTRICT'

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, Capistrano Bay Park and Recreation District hereby grants and conveys to the SOUTH EAST REGIONAL RECLAMATION AUTHORITY, a perpetual non-exclusive easement and right-of-way for drainage facilities purposes, including, specifically, but not by way of limitation, the right to lay, construct, reconstruct, remove and replace, renew, inspect, maintain, repair, improve, relocate and otherwise use a drainage culvert or culverts together with incidental appurtenances, connections, fences, and structures in, over, under, upon, along, through and across the real property hereinafter described, including rights of ingress and egress across adjacent property of the owner.

Said easement shall lie in, over, under, upon, along, through and across such certain real property situated in the County of Orange, State of California, described in Exhibit "A" attached hereto and by this reference incorporated herein, together with the right to enter upon and pass and repass over and along said strip of land for the construction, operation and maintenance of the facilities to be constructed in said easement by the SOUTH EAST REGIONAL RECLAMATION AUTHORITY.

It is understood and agreed that the easements and rights-of-way acquired herein are acquired subject to the rights of the owner, their successors and assigns to use the surface of the land within the boundary lines of such easements and rightsof-way to the extent that such use is compatible with the full and free exercise of said easement and rights-of-way by the SOUTH EAST REGIONAL RECLAMATION AUTHORITY, provided, however, that no streets, alleys, roadways, fences, block walls, or other structures or other improvements shall be constructed upon, over, and along said easement and right-of-way without first obtaining the consent of the SOUTH EAST REGIONAL RECLAMATION AUTHORITY. SOUTH EAST REGIONAL RECLAMATION AUTHORITY does hereby agree that it will not unreasonably withhold such consent.

Said easement shall terminate at such time as there is no reasonable necessity for a drainage channel and culvert to carry or divert water from its normal drainage course.


