

EASEMENT DEED

CIVIC

For a valuable consideration, receipt of which is hereby acknowledged, the LOS ANGELES COUNTY FLOOD CONTROL DISTRICT, a body corporate and politic (hereinafter referred to as DISTRICT), does hereby grant to the STATE OF CALIFORNIA, acting by and through its agent, the Department of Transportation (hereinafter referred to as STATE), a perpetual easement for highway purposes, a pipeline easement for transportation of oil, gas, petroleum or water purposes, together with a temporary construction easement in, on, over, under and across the real property in the City of La Mirada, County of Los Angeles, State of California, described in Exhibit A and shown on and delineated on Exhibit B, both attached hereto and by this reference made a part hereof.

Lands abutting said freeway shall have no right or easement of access thereto; provided, however, that part of the remaining lands of said parcel shall abut upon and have access to an adjoining frontage road which will be connected to the main thoroughfare of the freeway only at such points as maybe established by public authority.

The above-mentioned easements conveyed herein are subject to the following reservation and conditions:

- a) DISTRICT reserves the paramount right to use said land for flood control purposes.
- b) STATE agrees that it will not perform or arrange for the performance of any construction or reconstruction work, in, on, over and across the land herein-described until the plans and specifications for such construction and reconstruction works shall have first been submitted to and been approved in writing by the Chief Engineer of the DISTRICT. Such approval by DISTRICT shall not be interpreted or inferred as an endorsement or approval as to the design, accuracy, correctness, or authenticity of the information shown on the submitted plans and specifications. Furthermore, such approval cannot be relied upon for any other purpose or by any third party for any reason whatsoever. DISTRICT does not accept ownership or responsibility for the improvements,

- c) STATE agrees that it shall indemnify, defend and hold harmless DISTRICT, its officers, agents, and/or employees, from any and all liability, loss, or damage to which DISTRICT, its officers, agents, and employees may be subjected as the result of any act or omission by STATE, it's officers, agents, employees, or contractors, arising out of the exercise by STATE, its officers, agents, employees, or contractors of any rights granted to it by this instrument.
- d) It is expressly understood that DISTRICT will not be called upon to construct, repair, maintain, or reconstruct any structure or improvement to be erected or constructed pursuant to this Easement Deed.
- e) The provisions and agreements contained in this Easement Deed shall be binding upon STATE, its successors, and assigns

To the extent any lawful assessment be levied pertaining to the areas to which these easements apply and to the extent that the assessments is based on the structures and improvements being constructed under the authority of these easements and provided further that the assessment be levied following STATE's exercise of the easement rights to construct such structures and improvements, STATE agrees to pay on behalf of DISTRICT that part of any such assessment levied against DISTRICT, which is based on the value contributed to that area by STATE's said improvement.

LEGAL DESCRIPTION

Caltrans Parcel 79884-1 [LACFCD Parcel No. 576GE] (Easement for highway purposes):

That portion of that certain parcel of land in Section 27, Township 3 South, Range 11 West, Rancho Los Coyotes, as shown on map recorded in Book 41819, pages 141 to 185, inclusive, of Official Records, in the office of the Registrar-Recorder/County Clerk of the County of Los Angeles, described as Parcel No. 576, Amended, in a Final Order of Condemnation, had in Superior Court Case No. 877970, a certified copy of which was recorded on August 10, 1967, as Document No. 3448, in Book D3732, page 66, of said Official Records, lying southwesterly of the following described line and its northwesterly prolongation:




