The Plaintiff in the above entitled proceeding, having paid into Court for the benefit of Defendants Masami Hiroshima and Yoniko Hiroshima, the sum of \$70,299.56, the total amount of compensation awarded by the Court for the interests of said above named individuals in and to the parcels of real property described in Plaintiff's Complaint as Parcels C5-305, C5-305.1, C5-305.2, C5-305.3 and C5-305.4, together with any and all improvements thereon pertaining to the realty and for all interests and damages of every kind and nature suffered by said above named individuals by reason of the taking of fee title simple absolute for the establishment of a flood control channel in Parcel C5-305 and a perpetual easement in Parcels C5-305.1, C5-305.2, C5-305.3 and C5-305.4;

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED, that the following described parcels of real property be, and the same are hereby condemned as herein above set forth for the use and purposes set forth in said Complaint, to wit: a flood control channel for public use, the said real property being situate in the County of Orange, State of California, and more particularly described as follows:
