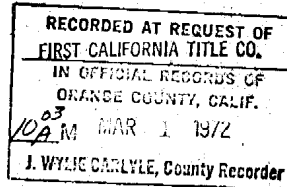

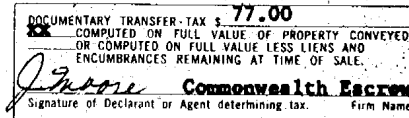

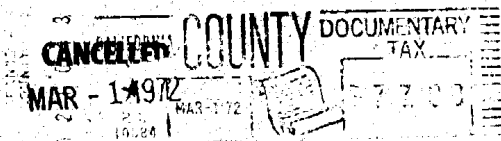

Beginning at the Northeast corner of said Lot 92; thence South 9° 30' 20" West 327.25 feet along the Easterly line of said Lot 92 to an angle point therein, thence South 13° 08' West 106.62 feet along the Easterly line of said Lot 92; thence North 74° 41' West 253.86 feet; thence North 32° 57' 40" West 150.66 feet to a point in the Northerly line of said Lot 92, said point being on a curve concave Southerly having a radius of 130.00 feet, a radial line through said point having a bearing of North 40° 50' 28" West; thence Northeasterly along said curve through a central angle of 26° 12' 48" a distance of 59.48 feet to a point in a line tangent; thence North 75° 22' 20" East 170.34 feet along the Northerly line of said Lot 92 to the beginning of a tangent curve concave Northwesterly having a radius of 220.00 feet; thence Northeasterly along said curve through a central angle of 35° 54' a distance of 137.85 feet to a point in a line tangent; thence North 39° 28' 20" East 116.12 feet along said tangent line, being along the Northerly line of said Lot 92 to the point of beginning.

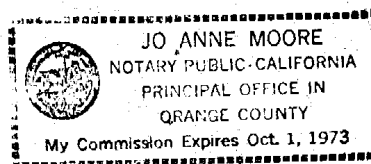
