Set 2" I.P. at all tract corners 12" below surface unless otherwise noted.
Set 1" I.P. at all rear lot corners unless otherwise noted.
Set 2" I.P. 8" below the surface with spike & washer in the finished surface at all centerline intersections, beginning and ending of curves, termination of streets and alleys, unless otherwise noted.
Ties to centerline monuments will be made and a copy of said ties furnished to the County Surveyor.
Monuments set along Masonary Walls to be offset 1 ft. from true Lot corner on lot lines produced.
