- b. An action commenced May 8, 1962 in the Orange County Superior Court, Case No. 103767, entitled The People of the State of California, acting by and through the Department of Public Works, plaintiff, versus Southern California Edison Company and others, defendants, to condemn a portion of said land, therein designated as Parcels 1A, 1B for freeway purposes and Parcel 1C for an easement for construction, reconstruction, operation and maintenance of a road. Notice of the pendency of said action was recorded May 8, 1962 in Book 6101, page 811 of said Official Records.
- 2. Grantee, by acceptance of this instrument, agrees that this easement shall be exercised in such a manner so as not to unreasonably interfere with District's use of its property.
- 3. Grantee, by the acceptance of this instrument, agrees to hold harmless and indemnify District, its successors and assigns, from and against all claims, demands, actions, loss, damage, expense and liability, arising from or growing out of loss of or damage to property, or injury to or death of persons, resulting in any manner whatsoever, directly or indirectly, by reason of the exercise of the rights granted; provided, however, that this covenant shall not apply in those instances where such claims, demands, actions, loss, damage, expense and liability are proximately caused in whole or in part by any negligence of District.
- 4. The above described property is to be used for the purposes herinabove specified, and in the event said land is not used for such purposes, it shall thereupon, ipso facto, revert to District, its sucsessors or assigns.

5. The Grantee agrees to use the above described real property for road purposes only and agrees to prohibit the parking of any type of vehicle on said real property and that the use thereof will mot interfere with the District's normal use of the road or with the emergency movement of heavy equipment thereon.
