On motion of Supervisor Gordon, duly seconded and carried,  
the following Resolution was adopted:

BE IT RESOLVED that Deed of Right of Way dated November 28th,  
1949 from The Irvine Company, Grantor to the County of Orange, to  
open a portion of that certain highway commonly known as Mesa Drive,  
in the Fifth Road District, a public purpose, covering the following  
described property to-wit:

A strip of land sixty (60) feet in width and being thirty (30)  
feet on each side of the following described center line:

Beginning at the Southerly corner of Tract No. 706, as shown  
on a Map thereof recorded in Book 21, Page 25, Miscellaneous Maps,  
Records of Orange County, California, said point of beginning being  
the intersection of the center line of Mesa Drive with the Southwest-  
erly prolongation of the Southeasterly line of Lot 164, said Tract  
No. 706, as shown on said Map of Tract No. 706, and running thence  
from said point of beginning, S. 50° 11' 45" E., along the Southeast-  
erly prolongation of said center line of Mesa Drive, 992.65 feet to the  
center of Block 51 of Irvine's Subdivision, as shown on a Map thereof  
recorded in Book 1, Page 88, Miscellaneous Record Maps, Records of  
Orange County, California,

be and the same is hereby accepted and ordered recorded.


