Subject to all reservations, covenants and conditions set forth in deed to Delhi Drainage District dated January 28, 1929, recorded in Book 246, page 495 of Official Records of Orange County, California, and as set forth in Agreement dated January 11, 1949, recorded in Book 1804, page 432, of Official Records of said Orange County, each and all of which are incorporated herein by reference, and subject also to all other reservations, covenants, conditions, easements, rights of way and rights of record affecting the above described property, which are of record as of January 19, 1961.

That the Grantor herein hereby reserves from the foregoing conveyance in favor of itself and its successors and assigns, the right at any time hereafter to relocate the easement hereinabove described, or any part thereof, so as to cause the drainage waters transported therein to flow into Newport Bay by the most practical direct route, subject to the following conditions:

- 1. That the Grantor shall cause a flood control facility to be constructed in and along such relocated route in accordance with such plans and specifications therefor as shall be approved in writing by the Orange County Flood Control Engineer prior to the commencement of any construction work.
- 2. That all costs in connection with the construction of said relocated flood control facility shall be borne by the Grantor.
- 3. That upon the completion of such new construction the Grantor shall convey to the Grantee, in writing, said new flood control facility together with an easement in and along said relocated route for the reconstruction, repair, maintenance and operation thereof for flood control purposes, and concurrently with said conveyance, the Grantee covenants and agrees to cause to be abandoned or quitclaimed to or in favor of the Grantor, or its successors and assigns, all portions of the easement hereinabove described no longer needed for flood control purposes.
