IRREVOCABLE OFFER TO CONVEY EASEMENT

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

THE IRVINE COMPANY, a West Virginia corporation (owner), and GEORGE C. LANE, STEVEN G. LANE and CHRISTOPHER JONES (lessees)

hereby IRREVOCABLY OFFER TO DEDICATE to ORANGE COUNTY HARBORS, BEACHES AND PARKS DISTRICT, an easement and right of way for RECREATIONAL. purposes in, on and over the real property in the County of Orange State of California, described as:

Parcel GA 546-3-2

A strip of land 20.00 feet in width, in the County of Orange, State of California, Lying within Lot 148, Block 5 of the Irvine 5 Subdivision as shown on a map recorded in Book 1, Page 88 of Miscellaneous Maps and Lots 101, 102 and 103 in Tract 706, as shown on a map recorded in Book 21, Page 25 of Miscellaneous Maps, both on record in the Office of the County Recorder of said Orange County, California; said strip is adjoining and lying Easterly and Northerly measured at right angles from the following described line:

Beginning at the northeasterly terminus of that line described as being parallel with and 900.00 feet Northwesterly as measured at right angles from the northwesterly line of said Tract in a grant deed to the County of Orange recorded June 30; 1958 in Book 4332, Page 308 of Official, Records of said County; thence Southwesterly along said parallel line to the northeasterly line of the land described as Parcel 215 granted to the Orange County Flood Control District, September 27, 1961, per a deed recorded in Book 5862, Page 311 of

Official Records of said County; thence Southerly along the easterly line of said Barcel to the southeasterly prolongation of the center-line of Orchard Drive as shown on a map of Tract 456 recorded in Book 17, Page 9 of Miscellaneous Maps, records of said County; thence Southerly and Westerly along the northerly and easterly line of the land described as Parcel 214A granted to the Orange County Flood Control District per a deed recorded October 31; 1961 in Book 5897, Page 339 of Official Records of said County, to an intersection with the centerline of Mesa Drive, 60' wide, per Tract 706; thence Southerly and Easterly along the northerly and easterly line of that certain land described as Parcel 102.1 granted to the Orange County Flood Control District recorded November 8, 1961 in Book 5906, Page 516 of Official Records of said County.

Said strip terminates 10.00 feet Westerly and at right angles from the westerly right of way line of Birch Street as shown on said Tract 7.06.

EXCEPTING THEREFROM that portion lying Northeasterly of the southeasterly prolongation of the centerline of Orchard Drive as shown on a map of Tract 456 recorded in Book 17, Page 9 of Miscellaneous Maps, records of said County.

It is mutually understood and agreed that the said offer may be accepted by Resolution of the Board of Supervisors of said District whenever, in the judgment of said Board, the property is needed for It is further understood and agreed that upon such acceptance by said District, it shall mail or deliver a copy of its resolution of acceptance to the then owners at the address shown on the latest secured assessment roll in the County where said property is located, and within 60 days thereafter said owners shall remove any and all permanent structures that are affixed to the above-described strip of land, and if same are not removed within said 60-day period said owners shall hold the said District free and harmless from any and all liability for its destruction or removal of same. It is further understood and agreed that this offer is irrevocable and shall be absolutely and perpetually binding upon the undersigned owners, their heirs, successors and assigns. It is further understood and agreed by the parties hereto that the above-described easement shall terminate on January 31, 2027. Upon acceptance and use of above easement by said District, said District shall be responsible for providing adequate security fencing between above-described easement area and adjoining southwesterly property currently leased for a golf course development between above-stated owner and lessees. Grantors, for themselves, their heirs, successors and assigns, do hereby release grantee, its offi-cers, employees and agents, from any and all liability arising out of the use of said land for the purposes stated or implied herein.
