IN RE: DEED OF RIGHT OF WAY (DELHI ROAD)

On motion of Supervisor West duly seconded and carried Deed of Right of Way from Ida S. Miles et al in the Fifth Road District commonly known as Delhi Road was duly accepted and daclared a public highway which said road is more particularly described as follows:

A strip of land sixty (60) feet in width and being thirty (30) feeton each side of the following described center line:

Beginning at a point in the North line of Lot 10 of the Williams Tract, as shown on a Map thereof recorded in Book 30, page 14 of Deeds, Records of Los Angeles County, California, which said point is distant S. 87° 44' 45" W., 266.30 feet, measured along said North line of Lot 10, from the Northeast corner of said Lot 10 of the Villiams Tract said point of beginning being the beginning of a curve tangent to said North line of Lot 10, concave Northwesterly and having a radius of 250 feet; and running thence from said point of beginning Northeasterly along said curve through a central angle of 39° 4' 45" 172.70 feet to a line tangent; thence N. 48° 10' E., along said tangent line 216.91 feet to the beginning of a curve tangent concave southeasterly and having a radius of 250 feet; thence Northeasterly along said curve through a central angle of 41° 40' 181.50 feet to a line tangent which is parallel with and distant North 30 feet, measured at right angles, from the forth line of Section 26, T. 5 S., R. 10 W.

DEED OF RIGHT OF WAY

DELHI ROAD

COUNTY OF CRANGE, Ss. WHEREAS, it is the intention of the Board of Supervisors of Orange.

County to relocate a portion of that certain public highway commonly known as DELHI ROAD in the Fifth Road District, and

WHEREAS, the necessary Right of Way for said relocation is more particularly described as follows:

A strip of land sixty (60) feet in width and being thirty (30) feet on each side of the following described center line:

Beginning at a point in the North line of Lot 10 of the Williams Tract, asshown on a Map thereof recorded in Book 30, page 14 of Deeds, Records of Los Angeles County, California, which said point is distant S. 87° 44' 45" W., 266. To feet, measured along said North line of Lot 10, from the Northeast corner of said Lot 10 of the Williams Tract; said point of beginning being the beginning of a curve tangent to said North line of Lot 10, concave Northwesterly and having a radius of 250 feet; and running thence from said point of beginning, Northeasterly along said curve through a central angle of 39° 34' 45", 172.70 feet to a line tangent; thence N. 48° 10' E., along said tangent line, 216.91 feet to the beginning of a curve tangent, concave Southeasterly and having a radius of 250 feet; thence, Northeasterly along said curve

through a central angle of 41° 40', 181.80 feet to a line tangent, which is parallel with and distant North, 30 feet, measured at right angles, from the North line of Section 26, T. 5.5., R. 10 W., S. B. B. & M.

NOW, THEREFORE, in consideration of the relocation of said highway as above described, and of the benefits to accrue to us and each of us, by such relocation, we the undersigned, owners, occupants and claimants of land required for highway purposes on the line of the foregoing designated route, hereby signify our approval of the relocation of said highway, and do hereby consent thereto; and do hereby grant and dedicate an easement for public road and highway purposes in the lands belonging to us and each of us, so far as the same may be required for such highway, to said Orange County, to that purpose and for the use of such highway, and we hereby waive all claim for damages for and on accounts of thesame.


