FINAL ORDER OF CONDEMNATION

Beginning at the point of intersection of the center line of Placentia Avenue as described in the deed to the County of Orange, recorded August 2, 1951 in book 2212, page 183 of Official Records, with the northerly line of said Lot 28; thence Easterly 283.00 feet along the northerly line of said Lot; thence Southerly 248.00 feet at right angles to said northerly line; thence Westerly, parallel to the northerly line of said Lot 28, to a point of intersection with the center line of said Placentia Avenue; thence northerly along said center line to the point of beginning.
