GRANT DEED

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

HENRY J. SIEVERS and FERN O. SIEVERS, husband and wife,

do hereby GRANT to the COUNTY OF ORANGE the real property in the County of Orange,
State of California, described as:

An undivided one-half interest in that portion of
Lot 28 of the "Potts, Borden and Sidwell Tract", in the
County of Orange, State of California, as shown on a map
recorded in Book 4, page 624 of Miscellaneous Records of
Los Angeles County, California, described as follows:

Beginning at the intersection of the centerline of Placentia Avenue
(now known as Manchester Avenue) as described in the deed to the County
of Orange, recorded August 2, 1951, in book 2212, page 185 of Official
Records in the office of the County Recorder of said Orange County, with
the north line of said Lot 28; thence, Easterly 591.10 feet along the
north line of said Lot 28 to an intersection with the northwesterly line of
the 630.00 foot wide strip of land described as "Parcel 2", in the deed
to the County of Orange, recorded May 25, 1932 in book 557, page 264 of
Official Records of said Orange County; thence, Southwesterly 392.13
feet along said northwesterly line to an intersection with the northerly
line of that certain land described as "Parcel 1" in the deed to the
State of California, recorded November 6, 1962, in book 6311, page 631 of
Official Records of said Orange County, said northerly line being described
as "N. 88° 50' 38" W. 409.58 feet"; thence, Westerly along said northerly
line and its westerly extension to an intersection with the centerline of
said Placentia Avenue (now known as Manchester Avenue); thence, Northerly
along said centerline to the point of beginning.
