It is understood and agreed that the easement and rightof-way acquired herein is acquired subject to the right of the

shall be constructed upon, over and along said easement and

No fill or paving of any nature shall be placed or maintained over the surface of the ground, nor shall any earth be removed from the cover of said pipeline after construction. without first obtaining the written approval of the SANTA MARGARITA WATER DISTRICT.


